The objectives of this audit are as follows:

To evaluate the implementation, including effectiveness of **SURIA CENTURY RESOURCES SDN BHD** on MS 2530-3:2013 Malaysian Sustainable Palm Oil (MSPO) documentation. It shall include at least the following:

- a. Information and evidence about conformity to all requirements of the applicable management system standard or other normative document;
- b. Performance monitoring, measuring, reporting and reviewing against key performance objectives and targets (consistent with the expectations in the applicable management system standard or other normative document);
- c. The **SURIA CENTURY RESOURCES SDN BHD** MSPO and performance as regards legal compliance;
- d. Operational control of the SURIA CENTURY RESOURCES SDN BHD processes;
- e. Internal auditing and management review (if applicable);
- f. Management responsibility for the SURIA CENTURY RESOURCES SDN BHD policies;
- g. Links between the normative requirements, policy, performance objectives and targets (consistent with the expectations in the applicable management system standard or other normative document), any applicable legal requirements, responsibilities, competence of personnel, operations, procedures, performance data and internal audit findings and conclusions.

EXECUTIVE SUMMARY

Stage 2 Audit was satisfactorily conducted to evaluate MSPO implementation at SURIA CENTURY RESOURCES SDN BHD. The Organisation area covering Sg Imbak Estate with the size of 173.70 Ha, Sg Millian Area AB with the size of 254.22 Ha, Sg Millian Area C/E with the size of 214.11 Ha and Sg Millian Area D with the size of 260.02 Ha.

Stage 2 of MSPO certification was satisfactorily conducted by NIOSH Certification on 27th - 29th January 2020. NIOSH Certification is a certification body accredited by Standards Malaysia which providing a comprehensive certification services system mainly for management system of occupational safety and health, environment, quality and MSPO for various industries.

During the Closing Meeting held on 29th January 2020, the overall results of the audit are as follow:

AUDIT METHODOLOGY & AUDIT PROGRAMME

The assessment was conducted involving estates under **SURIA CENTURY RESOURCES SDN BHD.** The minimum manday has been justified as per ABC-OPMC 2 (Audit Duration for CB Operating Oil Palm Management Certification under MSPO scheme). The audit covers documentation review, internal policies and procedures, management system as well as records review in compliance with the audit criteria requirements based on initial review self-questionnaire and Stage 1 Audit assessment, the risk factor medium (1.5) is determined.

The Stage 2 audit assessment has been conducted on sampling based on sampling size $1.5\sqrt{4}$ calculation resulted of 3 sampled estates. The assessment were cover documentation and records review, physical field observation covering all plantation processes, workshop, chemicals store, waste management, boundary & buffer zones, workers housing, stakeholders consultation, interview with internal & external stakeholders, workers and contractors.

SUMMARY OF AUDIT FINDINGS

During the audit closing meeting held on 29th January 2020, the overall results of the audit are as follows:

LOCATION AND MAP


1. LOCALITY MAP




2. ESTATE MAP (Area AB)










Sungai Imbak Estate (173.70 Ha)
