EXECUTIVE SUMMARY

Transfer cum surveillance audit for the third year annual surveillance audit was satisfactorily conducted to evaluate MSPO implementation at Saremas 2 Palm Oil Mill, which located in in the Miri District Sarawak, Malaysia. The mill can be assessed by using the Bintulu - Miri Road about 115km from Bintulu Town. The mill function as MSPO certified crop receiver and processing the certified crop to produce certified CPO and PK. Audit team has verified the implementation by site inspection, interview with personnel for accessing their understanding towards the MSPO requirements and documentation checking.

The transfer cum surveillance audit has assessed the conformity status against the standard and confirmed that the mill's certified activities fall within the accredited scope of certification of NIOSH Certification. The mill has successfully maintained its management system as accordance with the standards and during transfer review, the Saremas 2 Palm Oil mill's accredited certification is still valid in terms of authenticity, duration and scope of activities covered by the MSPO management systems. MSPO Certificates was issued previous certification bodies and valid until 11.04.2021, MSPO Cert No CU-MSPO MS2530-4-846691. Based on previous report, the non-conformity raised regarding the availability of first aid kit was adequately closed as assessed by the audit team, thus is no pending non conformity raised.

The reason for seeking certification body transfer was to reduce the risks of certification by not only focusing the same certification body for auditing since the company was certified with different standards. Transfer of certification body was verified by the audit team.

COMPANY BACKGROUND

Saremas 2 Palm Oil Mill a subsidiary company of Perlis Plantation Oil Palms Berhad started operation on 1st February 2000. It is located at Lot 35 BatangSuai, Sawai Land, Miri. At present, we are operating at 45 Mt/hour. Major supplier of FFB is from our own estate which accommodates 100% of the total crop. Our final products are Crude Palm Oil (PO) and Palm Kernel (PK). Both products are sold to Bintulu Edible Oil (BEO) for further refining and crushing process.

Currently, Saremas 2 Palm Oil Mill have 14 staffs including 2 executives. For processing, SPOM 2 have 92 workers with 27% (local) and 73% (Indonesian). During normal mill operation, 2 shifts will operate the processing from 7.00am - 3.00pm and 3.00pm - 11.00pm. The operating hours does change depend on the high or low crop season.

AUDIT METHODOLOGY & AUDIT PROGRAMME

The assessment was conducted involving mill under **PPB OIL PALMS BHD**. The minimum manday has been justified as per ABC-OPMC 2 (Audit Duration for CB Operating Oil Palm Management Certification under MSPO scheme). The audit covers documentation review, internal policies and procedures, management system as well as records review in compliance with the audit criteria requirements.

The **Surveillance3 Audit** assessment has been conducted based on individual certification. The assessment was cover documentation and records review, physical field observation covering all plantation processes, workshop, chemicals store, waste management, boundary, workers housing, stakeholders consultation, interview with internal & external stakeholders, workers and contractors.

SUMMARY AUDIT FINDINGS

During the audit closing meeting held on 18th April 2019, the overall results of the audit are as follows:

The audit team has satisfactorily verified the corrective action plan provided by the client. The effectiveness on the action plan for the corrective action will be reviewed by NIOSH Certification's auditors during the next surveillance audit.

Review and follow-up on previous audit findings

There was THREE (3) Area of Concern (AOC) raised during Stage 1 Audit by the previous audit team. The auditee has made a preparation to further improve the management system and operations of smallholders of **PPB OIL PALMS BHD** based on comment and verbal findings.

Stakeholders Consultation Session

Stakeholder consultation began with notification of upcoming assessment by official letter one month earlier to identified stakeholders. Emails, phone call and official letter were sent to applicable interested stakeholders. Audit team then visited some stakeholders to obtain positive / negative information or any issues in connection with **PPB OIL PALMS BHD**

It was started with a slide presentation by NIOSH Certification explaining about the objectives of the MSPO certification scheme and purpose of stakeholder consultation. Agenda of discussion including legal compliance, environmental protection, biodiversity conservation, safety & social responsibility and development of community. No major adverse issue been raised as consulted during the audit. All positive and negative inputs from stakeholders has been discussed with management of **PPB OIL PALMS BHD** with proper justification and adequate action plan by the management team to address the issue.

LOCATION AND MAP




Figure 1: Mill layout forSaremas 2 Palm Oil Mill for PPB Oils Berhad




Figure 2: Location Map for the Saremas 2 Palm Oil Mill in Sarawak Region, Malays
